1. SWEEPSTAKES PERIOD: The Willows Takes Flight Sweepstakes (the "Sweepstakes") will begin at 12:00 a.m. P.T. on Monday, September 7, 2026 and end at 11:59 p.m. P.T. on Friday, October 9, 2026 ("Sweepstakes Period").

2. SPONSOR: The Sweepstakes is sponsored by Regency Centers, L.P. ("Regency" or "Sponsor"), One Independent Drive, Suite 114, Jacksonville, Florida 32202.

3. ELIGIBILITY: To enter or win, Entrant must be a legal U.S. resident and who is 18 years of age or older as of September 7, 2026 (the "Entrant"). Employees, officers, directors, and representatives of Regency Centers, L.P., its parent company, affiliates, subsidiaries, partners, joint venturers, licensees, service providers, advertising and sweepstakes agencies, those involved in the production, development, implementation, or handling of the Sweepstakes, or any agents acting on behalf of the above entities, as well as the immediate family members (parents, children, siblings, spouses) and/or persons living in the same household (whether related or not) of each above-mentioned individual, are NOT eligible to participate in the Sweepstakes. Method 2: Social Media Selfie Post. Visit any Willows Shopping Center store location and take a selfie showing you are there. Post the selfie as a feed post (not a Story) on Instagram or Facebook. Additionally, to qualify under this method, you must: (a) follow @willowsconcord on Instagram or @WillowsShoppingCenter on Facebook; (b) tag @willowsconcord (Instagram) or @WillowsShoppingCenter (Facebook) in your post; and (c) include the hashtag #WillowsTakesFlight. Limit: one (1) entry per store location, per social media platform. Visiting

one of the designated new stores listed above in the first method earns double (2) entries per visit, per social media platform.

Entrants may use both methods and may visit as many different store locations as they choose during the Sweepstakes Period. Each qualifying visit to a different store constitutes a separate entry.
